copies of the following documents from 23<sup>rd</sup> March to 8<sup>th</sup> April 2013:-

(a) HSLC/Matriculation Admit Card for proof of age.

(b) Mark Sheets and Pass Certificates from HSLC onwards till required qualification.

(In the absence of Degree Pass Certificate, Provisional Certificate of Board/ University must be submitted).

(c) I.I., SC/ST, BT, Phy.Handicapped & Internship Completion certificates (if applicable).
