1. The result of the Competitive Examination for the post of Inspector of Motor Vehicle, Class-II, (Advt.No. 12/2012-13) is declared in Three parts. Part -I - Merit list of successful candidates to be recommended to Government. Part-II - Category wise list of candidates to be kept on Waiting list. Part-III - List of unsuccessful candidates.
2. The provisional result of the Competitive Examination for the post of Inspector of Motor Vehicle, Class-II, (Advt.No. 12 / 12-13) held on 02-12-2012 was declared on 18-04-13 and Corrigendum on 17-06-13. As per this result, the applications of the candidates who were declared provisionally successful were scrutinized with reference to the provisions of the Recruitment Rules, Recruitment (Examination) Rules and Advertisement. The Physical Measurement Test of these provisionally successful candidates was conducted during 06-05-13 to 08-05-13 and 24-06-13. In view of the above scrutiny and physical measurement test, the list of candidates eligible for the Oral Interview was declared on 01-07-2013. The Oral Interview was conducted during 22-07-13 to 08-08-13. The final result is declared as under, taking into consideration the number of posts advertised for each category, the final marks of written examination and marks obtained in Oral interview i.e. total marks obtained by the candidates and the requirements of the Recruitment Rules / Recruitment (Examinations) Rules and provisions of the Advertisement.
3. (i) The Reserved Category Candidates (SC / ST / SEBC), who get either equal or more than minimum marks fixed as qualifying standard for general candidates, and have not availed of any relaxation in age, qualifying standard etc. have been selected against unreserved posts, as per the Government circular, G.A.D. No. PVS- 1099-MM-13-G4 dated 29-01- 2000 and PVS-102003-900-G4, dated 23-07-2004. Accordingly, SEBC candidates shown at Merit Nos. 19, 24, 32, 33 and 36, S.C. candidates shown at Merit Nos. 06, 20 and 37 are considered as General category candidates.

(ii) The Reserved Category Candidates (SC / ST / SEBC) who have secured their place in the Merit List of General category, but have availed the benefit of relaxation for the respective reserved category have been selected as Reserved Category candidates for the respective category. Accordingly, SEBC candidate shown at Merit No. 02, S.C. candidates shown at Merit Nos. 15 and 31 are considered as reserved

category candidates in their respective categories as they have availed the benefit of age relaxation.

(iii) In case of equal marks, the merit is assigned taking into consideration the date of birth (i.e. preference is given to the elder).

4. The following details are, at the time of declaration of this final result, relevant in respect of certain candidates who are treated as ineligible for the examination for one reason or the other. The brief details of these candidates are as under:

(i) All the candidates who had applied online were allowed to appear for the Written Examination without any scrutiny of the details given in the online applications. All the candidates were allowed to appear in the written Examination subject to the verification of the documents / certificates sent by them along with the application forms. The candidates, who were declared successful in the written Examination, were asked to send the application forms with all the requisite / stipulated documents / certificates etc.

(ii) The candidatures of 22 candidates have been cancelled by the Commission as they are over-aged or do not possess the requisite education qualification or do not possess requisite physical standard or did not remain present for physical measurement test. The necessary Orders for cancellation of their candidatures has been issued by the Commission separately on 01-07-2013.

(iii) The candidature of Kum. Panchal Nimishaben Dasharath, bearing E. No. 155, has been rejected for not producing original NCLC within the prescribed time limit.

(iv) The candidate, Shri Patel Vrajesh H., bearing E.No. 60, has been declared unsuccessful, as he remained absent in the Viva-Voce Test, as per the Inspector of Motor Vehicles, Class-II, in the Gujarat State Transport Department, Competitive Examination Rules, 2011, dated 16/12/2011 and amendments made thereafter from time to time.

5. (i) With regards to women reservation as provided for, in the Government Notification, G.A.D. No. GS/97/13/CRR/1096/2213/G-2, dated 9th April 1997 and G.A.D. Circular No. CRR/1096/2213/G-2, dated 22nd May, 1997, 20 women candidates (General-11, SEBC-05, S.C.-01 and S.T. -03) are required to be selected. As Against this 03 women candidates of General category and 01 woman candidate of SEBC category were available for the interview and only 02 women

candidates of General category have been selected. Hence, male candidates of their respective categories are selected against the posts reserved for women of respective categories, (item No. 2 of the G.A.D., Notification No. CRR/1096/2213/g-2, dated 22nd May, 1997).

(ii) The required No. of women candidates of SEBC and General Categories could not be selected even after relaxing 10 % of the minimum qualifying standard prescribed for the candidates of their respective categories.

(iii) Against total 04 posts reserved for women candidates of S.C. and S.T. categories, no women candidates were available for the interview.

(iv) The candidates at **Rank No. 50 and 51**, being female candidates of General category, have been selected after **relaxing the minimum qualifying standard prescribed for General Category candidates.**

(v) 01 post reserved for Ex-Serviceman remains vacant, as no candidate was available for the interview.

(vi) The candidate shown at Merit list No. 40 has been certified temporarily fit for one year by the M. & J. Institute of Ophthalmology, Civil Hospital compound, Ahmedabad. The Commission has decided to recommend the name of this candidate with a condition that he would bound by the decision by the Government that may be taken in future.
