On the basis of Haryana Civil Service (Judicial Branch) Main written Examination - 2012 held from 25.05.2013 to 27.05.2013 at Panchkula and interviews of qualified candidates held from 20.07.2013 to 26.07.2013, the Selection Committee of Punjab & Haryana High Court has finalised the result and recommended the candidates bearing following Roll numbers in order of merit in each category for appointment to the posts of Civil Judge (Junior Division) in the State of Haryana.
